PERSONNEL MANAGEMENT, RELATIONS:

- 1) Chief McBride received executive leadership training through the IAFF program during the month.
- 2) On August 9th, Governor Inslee issued Proclamation 21-14 which required all health care workers (including all District EMTs) to have completed their COVID-19 vaccinations (or receive exemption/accommodations) by October 18th. District staff worked to determine how it would achieve compliance with this mandate and provide guidance/direction to its members. This continues to be a significant effort for all parties involved.

EQUIPMENT & FACILITIES:



New Engine 83 being prepared for delivery.

1) Apparatus & Equipment:

- a. The replacement pumper (for Engine 83) has been transported to the local vendor, Hughes Equipment in Tacoma; it is being prepared for delivered to the District in September.
- b. Specifications for a replacement brush truck are being developed for bidding as per the 2021 Capital Repairs & Replacement Schedule.
- c. During August, Lt DeGagne arranged for a demonstration of battery-operated tools to evaluated their procurement and deployment on District apparatus. On August 10th, a battery-powered extrication tools were demonstrated at the Training Center.
- d. The Battalion 8 unit (3138) and Engine 83 (3130) were serviced during the month.
- e. The District's hydraulic rescue tools were serviced on August 11th.

2) Facilities:

- a. Several electrical and mechanical issues at Annex 8-3 were addressed and repaired during the month.
- b. Quotes for work on the District Residence facility are being sought for replacement of the deck structure and other exterior repairs, however, the construction market at this time is still very tight (both labor & materials). It is very difficult to obtain bids at a reasonable cost.

Priority #1: The Operations-Training & Safety Team, led by AC LeMay, shall ensure qualified staffing for a minimum of 2 Apparatus Driver-Operators (ADO) for each shift by December 2021.

- Staff working on assessment of staffing needs, including hiring of additional career FF-EMT ADO's; issue complicated
 with new COVID-19 pandemic issues (i.e. mandatory vaccinations, career/volunteer sick leave or leave of absence,
 training availability etc.).
- Significant limitation for staffing at Station 8-3 (Boston Harbor) in August (see above) due to ADO and officer limitations.
