Resolution 25-06 PROPERTY TAX LEVY ORDINANCE

BE IT RESOLVED BY THE COMMISSIONERS OF THURSTON COUNTY FIRE PROTECTION DISTRICT EIGHT AS FOLLOWS:

1. That the Thurston County Assessor has notified the Commissioners of Thurston County Fire Protection District Eight that the assessed valuation of real properties lying within the boundaries of the said District for the calendar year of 2026 is \$3,615,410,852. This includes the value of new construction of \$24,687,736. Furthermore, this figure is given by the Thurston County Assessor as a preliminary figure, and is stated to be subject to changes, which may affect the revenues of the District.
2. That the Honorable Board of County Commissioners of Thurston County, Washington, be and are hereby requested to make a levy for 2026 in the amount of \$ 7,431,079 which includes the District's regular levy of \$5,423,116 and the refund of \$7,963, plus the Excess levy identified in Section 3.(c) below for \$2,000,000; all in order to discharge the expected expenses and obligations of the fire district and in its best interest.
3. That the County Treasurer of Thurston County, Washington, be and is hereby authorized and directed to deposit and sequester the monies received from the collection of the tax levy specified in Section two (2) above in the amounts and funds specified below:
 - a) \$5,423,116 into the Expense Fund (6680) for the said District, and
 - b) \$7,963 into the Thurston County Treasurer Fund (1360) for payment of administrative refunds.
 - c) \$2,000,000 Excess levy as approved by the voters at the November 5, 2024 Election.
4. That one copy of this Resolution will be delivered to each of the following: Board of County Commissioners, Auditor of Thurston County, Washington, Treasurer of Thurston County, Washington, and Assessor of Thurston County, Washington.
