  - Training compliance for third quarter is 98%.
  - Chief LeMay attended a virtual class on property tax levies on September 14<sup>th</sup> and 15<sup>th</sup>.
  - On September 27<sup>th</sup>, Chiefs VanCamp, LeMay and Secretary Stumpf attended a webinar hosted by the Department of Labor & Industries regarding participation in their Firefighter Illness & Injury Reduction Program (FIIRE); the District is enrolled in this program which will help reduce its premiums for industrial insurance.
  - On September 28<sup>th</sup>, Chief VanCamp participated in a Washington Fire Chiefs' sponsored webinar on finding and addressing waste in the organization.

#### PERSONNEL MANAGEMENT, RELATIONS:

1) At the September 14<sup>th</sup> Board meeting, Chief LeMay provided a briefing on the status of volunteer responder programs in other fire departments in Thurston County as compared to the District's program.


