- 1) Chief McBride undertook IAFC leadership and mediator training during the month.
- 2) The South Bay Firefighters' Association meeting was held on May 3rd.

EQUIPMENT & FACILITIES:

1) Apparatus & Equipment:

- a. The Facilities & Equipment Team met on May 4th;
- b. Chief VanCamp met with the Thurston County Emergency Radio Network team on May 4th to begin to finalize design specifications for the new county-wide trunked radio system.
- c. The process for purchasing a replacement staff car (for Battalion 8), but, Washington State DES-Procurement has a delay on ordering & delivery of vehicles.
- d. Two new battery-powered positive pressure fans were received; these are the first of several battery-operated tools that will be procured, replacing gasoline-engine powered equipment. The two fans will be stored on Engines 81 & 83.
- e. Replacement thermal imaging cameras were tested by District staff during their live-fire training events.
- f. Engine 83 (3130) and Tender 82 (3135) underwent the annual pump testing on May 11th.

2) Facilities:

 After the second bid openings for the Station 8-1 septic system upgrades on May 25th, Chief VanCamp evaluated the bids, and based upon a recommendation of the project team, chose to terminate the project until such time that construction costs "returned to normal". Use of the septic system will continued to be monitored closely.

- c) Incentives to increase retention.
- Existing volunteer recruitment evaluation/selection has been completed and will constitute a new process starting on 1 June: a) existing volunteer selection is expected to meet "line level" IR&R needs (i.e. Firefighter-EMT), b) work remains to occur to assess durability, and c) work & assessment still needed to determine incentives and increased retention.
- The Operations-Training & Safety Team, led by AC LeMay, will evaluate the current District Officer Development Program and provide a recommendation for any modifications to Chief VanCamp by December 2021.
 - Previous ODP has been considered & reviewed; an extensive modification is required.
