DISTRICT MONTHLY REPORT: JULY 2020

ADMINISTRATIVE:

- 1) On July 27th, the Board held its second and last workshop on District financial planning. The outcome of the workshop included a 6-year financial plan of balanced expenditures and revenues and longer-term plan for capital project scheduling and funding. These goals form the "cap-stone" of over five years of comprehensive planning on staffing, deployment, operations and funding.
- 2) At their regular meeting on July 14th, the Board approved updates of *Policy 1-03 "Procurement, Expenditures & Audit Guidelines"* and *Policy 1-06 "Use of District Purchasing & Travel Cards"* and a new *Policy 1-07 "Federal Uniform Guidance Procurement Policy"*. The Board also rescinded the SARS-COV2 Covid-19 pandemic emergency declaration of March 2020.

PERSONNEL MANAGEMENT, RELATIONS:

1) On July 28th, the District and the County Training Officers' Committee recognized new graduates from the Thurston County Firefighter Recruit Academy. It was a novel process, all of which was done remotely over an internet feed using "Zoom". Our graduates Robert Dixon, Angelina Flynn, Jake Johnson, Coby Kubiak, Claudette Matunan and Christian Vladez participated from Station 8-1 along with several District chief officers. Johnson was awarded the Academy's *Outstanding Recruit Award*. Congratulations to Jake and all graduates!



- 2) At their July 14th regular meeting, the Board recognized Shift 4 for an outstanding response to a recent serious emergency call. The team on the shift included Chief Robinette, Lieutenants David Dodge and Jacob Zvirzdys, Firefighters Dustin McCann, Devin McCosh, Mitch Bourque, Shane Frost, Elliot Sheller and David Timmins, all of which did an excellent job!
- 3) The South Bay Firefighters' Association meeting was held "virtually" on July 6th.
- 4) The special projects grant from Thurston County Medic One was approved for the District, which will use the funds for member training on special technical operations support; this will allow our responders to better assist the Thurston County Special Operations Response Team (SORT) for incidents within the District.

EQUIPMENT & FACILITIES:

- 1) Apparatus & Equipment:
 - a. Engine 81 (3136) was placed back into service during the month after an extended servicing;
 - b. Engine 82 (3131) is awaiting repairs for damage sustained in an accident during June; it is being scheduled into the repair shop in August;

- c. Engine 84 (reserve-3124) is back at Station 8-3 awaiting repairs to its ladder rack equipment (not yet scheduled);
- d. Engine 83 (3130) will be shopped for a minor oil leak from the pump, but, is in service at this time (being monitored) awaiting shop scheduling.
- e. Hose testing was conducted during the month with several lengths of hose failing the test; Chief McBride is working on a proposal for purchase of replacement hose (the last significant purchase of hose was over 5 years ago).
